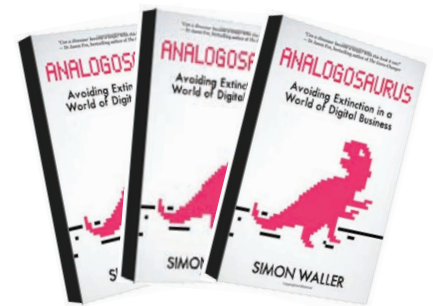


**SIMON WALLER** Founder, Mobial
